

Air Ambulance Promotions Ltd., Superdraw Terms & Conditions

Updated March 2021

1 Governance

- 1.1 The Superdraw is an additional jackpot draw to the Regular Lottery, operated and promoted by Air Ambulance Promotions Ltd. (registered address Rochester City Airport, Maidstone Road, Chatham, Kent, ME5 9SD), as a society lottery under the Gambling Act 2005.
- 1.2 Issued under registration with the Gambling Commission. Operating Licence No. 000-004674-N-100307. PML Holder: L Harris
- 1.3 Air Ambulance Promotions Ltd. is a wholly owned subsidiary company of Kent, Surrey & Sussex Air Ambulance Trust. Charity No. 1021367 registered in England and Wales. Company no. 2674568

2 General

- 2.1 The Superdraw is only available for entry to paying members of the Regular Lottery.
- 2.2 The Superdraw takes place every week, on a Wednesday. If the draw cannot be performed on a Wednesday, due to public holidays or unforeseen circumstances then the draw will be performed on the next available working day.

This draw is a jackpot rollover draw, so as and when there is a winner, it will be announced within 3 working days on the Kent, Surrey & Sussex Air Ambulance website aakss.org.uk/ways-to-give/lotteries-raffles/lottery/aakss-lottery-results/

A maximum of 3 draws may take place retrospectively at the discretion of the board of the society.

- 2.3 The following people may enter the Superdraw:
 - 2.3.1 Any individual over the age of 16 years who resides in or has a bank account in England, Scotland or Wales. Unfortunately, residents from overseas, Northern Ireland, the Channel Islands and the Isle of Man are unable to enter. By purchasing an entry, the individual confirms that they are 16 years of age or over. No entries should be sold to, or on behalf of, a person under the age of 16 years. Underage gambling is an offence.

- 2.3.2 Individuals who are already a paying member of Air Ambulance Promotions Ltd. Regular Lottery.
- 2.4 The maximum amount of chances permitted for this lottery, for any individual, is 20 per week.
- 2.5 All proceeds, after the deduction of legal prizes and expenses, shall be donated to the Kent, Surrey & Sussex Air Ambulance Trust.

During the 2019 – 2020 financial year, the proceeds for this lottery were spent as follows;

- Of the total proceeds, £269,989.74 (9%) was spent on the prizes offered for a winning chance in this lottery.
 - The expenses related to promoting and running this lottery totalled, £899,965.80 (30%)
 - The amount that was directly applied to the purpose of the society lottery (money given to the good cause) totalled, £1,892,930.46 (61%)
 - The total proceeds from the selling of tickets for the Superdraw, during the financial year of 2019 – 2020, totalled £2,999,886
- 2.6 Any application for entry into the lottery may be rejected for any reason by discretion of the Promoter.
- 2.7 Air Ambulance Promotions Ltd. holds customer funds in accounts separate from our business accounts. Funds are held in a mixture of current accounts and interest bearing accounts. These funds are not protected in the event of insolvency as such customer funds are considered segregated but not protected.
- 2.8 Any lottery entry may be terminated for any reason at the discretion of the Promoter.
- 2.9 The Promoter's decision is final in any matter regarding the lottery.

3 How to Play

- 3.1 Each entry costs £1 per draw. The member will be entered into the draw for which each subscription has been received in advance of the draw taking place. All advance payments received from the member will be held in account by Air Ambulance Promotions Ltd., and credited upon receipt to the relevant amount of draws in advance.



- 3.2 Each member will be issued a combination of 4 numbers within the range of 1-42, these will be allocated to their Superdraw membership and entered into the draw for as long as chances have been paid. This random combination of numbers will be created by a Random Number Generator built into the donorflex Lottery software. The donorflex Lottery is fully licensed and regulated by the Gambling Commission and their Random Number Generator (RNG) has been independently tested, using a variety of industry-standard statistical tests to produce truly random numbers.
- 3.3 Persons eligible may apply to play the Regular Lottery by entering online and completing an online application form, via a paperless method over the telephone or by completing a paper application form which will include the following information:
 - 3.3.1 The member's name, full address, telephone number, confirmation of age over 16, and a completed Direct Debit mandate in favour of the draw. Alternatively members may join by advance cheque or card payment, complete with name and address details and age confirmation.
- 3.4 The Direct Debit Guarantee applies to all Direct Debit arrangements. A copy of the Direct Debit Guarantee will be supplied to all members with their welcome pack. A member can cancel their Direct Debit at any time by notifying their bank or building society. Members should also notify Air Ambulance Promotions Ltd. of cancellation. Any funds held in advance and not used in draws by Air Ambulance Promotions Ltd. will be returned to a member upon request. No refund can be made in respect of subscriptions used in draws, unless as a result of our negligence.
- 3.5 Following acceptance of membership, Air Ambulance Promotions Ltd. will issue all members with a letter stating their unique combination of Superdraw numbers allocated to them, and their membership number for the Regular Lottery that will be entered into all future draws that payment has been received for. Members paying by Direct Debit will also receive a document detailing the Direct Debit instruction, including frequency and amount of payments amongst other relevant detail as required by the Direct Debit Guarantee.
- 3.6 It is the responsibility of the member to check their details held by us are correct, and to inform us of any errors in the information held. Members are also responsible for informing us of any future changes in their personal details, to which we will update the details on our system within 3 working days of the notification.
- 3.7 Members should note the date and frequency of payments and ensure that funds are available to cover Direct Debit payments when

due. Air Ambulance Promotions Ltd. will not be liable for any charges incurred by the member, unless as a result of our negligence.

4 Draws & Prizes

- 4.1 There is one prize available in the Superdraw each week. This prize is a rollover jackpot and the jackpot is created each week by taking 9% of each £1 paid entry.

Air Ambulance Promotions Ltd. has the right to change the contribution to the jackpot from each £1 payment at any time, in line with the Gambling Act 2005.

- 4.2 The jackpot is determined each week by the number of paid entries and the number of times the jackpot prize has been rolled over (as described in 4.4)
- 4.3 Each week, all paid entries in the Superdraw will be entered into the draw and the donorflex Lottery Random Number Generator will select a combination of four numbers as the winner.

If the combination that is selected matches a combination that is owned by a paying member then they will win the jackpot prize for that week.

- 4.4 If the four number combination that is drawn by the Random Number Generator does not make a complete match to a members paid entry, then the jackpot prize will rollover over to the following week.

The draw will continue to be operated each week and the jackpot prize will continue to rollover if the winning four number combination does not make a complete match to a members paid entry. This jackpot will rollover until it reaches a maximum of £25,000. At this point multiple draws will be made in a single week until a complete match to a paid entry is selected.

When this occurs, the relevant member wins £25,000, subject to clause 4.6.

- 4.5 As this lottery has a prize that is a rollover jackpot, it means that the likelihood of winning a prize each week is determined by which stage the jackpot amount has reached.

By taking the odds of winning any prize over the course of the 2019/2020 financial year it is determined that the odds of winning a prize in the Superdraw are 1 in 110,892.

- 4.6 An obligation in our licence means that we are only allowed to offer a maximum prize of £25,000. If the jackpot reaches this amount by

subsequent rollovers and the jackpot amount available due to this rollover is more than £25,000 then the additional amount will be added to the subsequent week's jackpot fund.

- 4.7 Only members who have paid subscription to the relevant draw will be eligible to win.
- 4.8 The draw is operated by a designated officer of Air Ambulance Promotions Ltd., and the draw is witnessed and the results recorded
- 4.9 Members will not accrue any debt to the lottery.
- 4.10 Air Ambulance Promotions Ltd. reserve the right to withhold payment of a prize if we are not satisfied as to the validity or legality of a member, pending further investigation into each case.
- 4.11 Following notification that a paying lottery member is deceased, all monies present on lottery plays will be returned to the estate of the deceased.
- 4.12 Prize monies will be paid by cheque within 20 working days, subject to satisfaction of section 4.6, and sent to the winner's registered address held by us following completion of the draw, with no requirement for winners to claim.
- 4.13 Should Air Ambulance Promotions Ltd. be unable to pay a winning member because we do not hold their correct details, and after exhaustive investigation which may include communication with the member's last known bank, we will after a period of 6 months, treat the winning monies as a donation to the Kent, Surrey & Sussex Air Ambulance Trust.
- 4.14 Winners' details, in brief, may be used to promote new membership and/or further lotteries.

6 Liability

- 5.1 Air Ambulance Promotions Ltd. will not be liable to a member for any loss or damage suffered to a member arising from:
 - 5.1.1 Any delays in payments received from members for entry into the lottery.
 - 5.1.2 Any delays or failure in the postal service or other delivery methods including emails used by Air Ambulance Promotions Ltd. or by members.
 - 5.1.3 Any failures in the banking system used to transmit payments to or from Air Ambulance Promotions Ltd.

6 Complaints

- 6.1 Complaints pertaining to the lottery draw should in the first instance be sent by post to

In the first instance a complaint will be dealt with by the manager of the lottery department. If necessary the complaint may be escalated to the designated Complaints Officer for the Kent Surrey & Sussex Air Ambulance Trust. Should the complaint not be satisfied at this point, it will be referred to the board of directors of Air Ambulance Promotions Ltd. After this, if the complaint is still not satisfied then the complaint will be referred to the Independent Betting and Adjudication Service (IBAS) whose decision will be final.

7 Law

- 7.1 These terms and conditions are the rules of Air Ambulance Promotions Ltd. Superdraw Lottery. By becoming a member you agree to be bound by these rules.
